

Indigenous Navigator

Overview of tools and resources

The Indigenous Navigator offers a range of tools and resources for monitoring indigenous peoples' rights that can be used in multiple ways. Some users will need only the questionnaires to generate data on indigenous peoples' human rights and development situation. Others will benefit from the broader range of tools and resources that offer extensive guidance and can be applied to a multitude of different areas of work.

Online questionnaires and a question database

- Community Questionnaires and National Questionnaires (see Training Module 7, 10 and 11)
- Key tools for indigenous communities and organizations as well as other actors who want to monitor
 the level of respect, recognition and fulfilment of indigenous peoples' rights. While some facilitation
 will be needed for communities to use the questionnaires (in most cases), the questionnaires are easily
 accessible and can be used by people with no human rights training online guidance for each question
 explains how to answer 1
- The questionnaires build on a systematic analysis of the UN Declaration on the Rights of Indigenous Peoples. Those who want to understand the technical approach behind the questionnaires can access information on which articles the specific questions monitor

Question Guides to the Community Questionnaire and the National Questionnaire

- Provide an overview of which UNDRIP articles, WCIP Commitments and SDG indicators each of the questions are linked to
- Provide guidance on how to answer
- The Question Guide for the Community Questionnaire provides further conceptual clarification around the rights being monitored what do the UNDRIP articles mean, etc.

Index tools

- The Indigenous Navigator National Index is a tool that serves to rank and illustrate countries' performance with regard to recognizing, respecting and fulfilling indigenous peoples' rights are laws, policies and government programmes in line with the UNDRIP?
- The **Indigenous Navigator Community Index** is a tool that serves to rank and illustrate countries' performance with regard to implementing and fulfilling indigenous peoples' rights what are communities' experiences?
